

## GFU Graduate School of Clinical Psychology Course Transfer Request Form (v10/25/19)

**Before you fill out this form, please make sure the course you hope to transfer meets the following criteria:**

1. Course was taken within past 3 (non-degree program) or 7 (degree program) years from an accredited institution.
2. Official Transcript shows a grade of "B" or higher.
3. Syllabus provided that was used during the class for which you are requesting a transfer. The syllabus must be from the same year and semester you took the class that is recorded on your transcript.
4. Transfer limitations not exceeded. (You are allowed 35 semester hours, of which 20 may be credited toward conferral of MA degree)
  - Transfer of psychology credit is limited to 30 semester hours.
  - Transfer of faith integration credits is limited to 10 semester hours.
  - Transfer of elective psychology courses is limited to 12 semester hours.
5. If partial credit is given for this course, you will need to contact the registrar's office to register for the class.
6. Course Transfer Decisions: Transfer requests received by May 1st will be notified prior to start of fall semester. Transfer requests received by October 1st will be notified prior to start of spring semester.
